What is your commitment?

To participate in the UN Global Compact, businesses are required to:

- Submit a **Letter of Commitment** addressed to the UN Secretary-General and signed by the organization's highest level executive stating their commitment to implement the Ten Principles of the UN Global Compact.
- Submit an annual <u>Communication on Progress (CoP)</u> a standardized questionnaire submitted through a
 digital platform. Subsidiaries are not required to submit a CoP.
- Pay an annual financial contribution.
