Do's 	Don'ts 
<p>Use the provided social media cards for the communication of your participation.</p> 	<p>Don't create your own social media graphic.</p>
<p>Request permission to use the "We Support" Endorser logo to communicate about your commitment. Use the online logo request system, and provide a sample, mock up, or screenshot for the logo placement. Permission to use the Endorser logo lapses if the participant is delisted from the UN Global Compact.</p> 	<p>Don't use the UN Global Compact logo as it is reserved for the UN Global Compact only. Participants can request the "We Support" logo through the online logo request system. The logo may not be sub-licensed to any other entity without the prior written consent of the UN Global Compact. Don't use the UN Global Compact logo if you're no longer a participant.</p> 
<p>Use the following phrasing with the "We Support" endorser logo:</p> <p>"Since (Join Year) (Company Name) has been committed to the UN Global Compact corporate responsibility initiative and its principles in the areas of human rights, labour, the environment and anti-corruption."</p>	<p>The logo and UN Global Compact name are not to be used in any manner that suggests or implies that the UN Global Compact has endorsed or approved of the activities, products, and/or services of the organization, or that the UN Global Compact is the source of any such activities, products or services. Please contact info@globalcompact.ch if you are unclear about the phrasing.</p>
<p>Ensure that the logo is placed in isolation from other logos in a manner that it is clear from the context to which the "We" refers to.</p>	<p>Don't use the logo out of context where it is unclear to which organization the "We" refers.</p>
<p>Have a clear space around the logo (50% or more of the width and height of the globe) and use the minimum sizes of the logo (height: 29 mm digital, 18mm printed)</p>	<p>Don't use a logo that is too small, and don't leave too little space around it. . Generally, per the Brand Guidelines, a participant's logo should not be placed on the same level as the Endorser logo.</p>
<p>Use the endorser logo with a clear connection to the mission, principles and/or activities of the initiative.</p>	<p>Don't use the endorser logo in any context of promoting or advertising products, services or in connection with fundraising and events/conferences in which the UN Global Compact is not a participant/host.</p>
<p>Use the "We Support" Logo for example, on websites and relevant print materials to communicate your commitment to the initiative and raise awareness of the UN Global Compact. Participants and stakeholders that have been authorized to use the Endorser logo on their website are strongly encouraged to link the logo to the UN Global Compact homepage.</p>	<p>Don't use the logo and name (UN Global Compact):</p> <ul style="list-style-type: none"> • as a component of an organization's own logo • in the header/footer of a website • on any social media platforms • in your email signatures • as a permanent graphical element of stationary, business cards, or other material • suggesting or implying a certification or seal of approval for activities, services and/or products
<p>Describe your engagement in the UN Global Compact as a "participant".</p>	<p>Don't refer to your organization as a "member" or a "partner" of the UN Global Compact.</p>
